

RoHS (Restriction of Hazardous Substances)

EC Directives 2011/65/EU (RoHS 2) and Supplementary Directive 2015/863/EU (RoHS 3) are intended to limit the use of certain hazardous substances in electrical and electronic equipment and regulate the use and marketing of hazardous substances in devices and electronic components.

Some of the substances used in electrical engineering are considered environmentally hazardous. They should be banned by the RoHS directive from the products. For this reason, RoHS should minimize the entry of these substances into the environment. This affects in particular the substances of ANNEX II:

- 1. Lead (Pb) (0,1 %)
- 2. Mercury (Hg) (0,1 %)
- 3. Cadmium (Cd) (0,01 %)
- 4. Hexavalent chromium (Cr+6) (0,1 %)
- 5. Polybrominated biphenyls (PBB) (0,1 %)
- 6. Polybrominated diphenyl ethers (PBDE) (0,1 %)
- 7. Bis (2-ethylhexyl) phthalate (DEHP) (0,1 %)
- 8. Butyl benzyl phthalate (BBP) (0,1 %)
- 9. Dibutyl phthalate (DBP) (0,1 %)
- 10. Diisobutyl phthalate (DIBP) (0,1 %)

(limit value: max. 0,1 % by weight) (limit value: max. 0,1 % by weight) (limit value: max. 0,01 % by weight) (limit value: max. 0,1 % by weight)

Please note the exceptions of the directive which apply to the above-mentioned substances and their quantity limits. To the best of our knowledge, we hereby certify that our products are in compliance with the directive 2011/65/EU (RoHS 2) and the supplementary directive 2015/863/EU (RoHS 3).
